## Professional History

Mr. Vaughan was admitted to practice law in California in December 1981 and in Nevada in 1985. He is admitted to practice before a number of different United States District Courts in several states. Defending Americans with Disabilities Act access litigation and consultation for a variety of California businesses on accessibility issues has been his primary area of practice for more than 15 years. Mr. Vaughan also owns and operates ADA Consultant Services which performs accessibility evaluations of both private and public facilities. He is a California Certified Access Specialist. He has been designated as a subject matter expert in disabled accessibility by the State of California.

Over the course of his career, Mr. Vaughan has represented numerous public entity and private clients.
